

# **Tearlach Productions LLC**

## **Rental Agreement**

**This is a binding agreement between Tearlach Productions LLC and below signed Renter. By signing, Renter understands and agrees to abide by the conditions and terms described herein.**

### **Insurance:**

Please email a certificate of insurance naming Tearlach Productions LLC as additionally insured three days prior to the start of the production.

### **Terms:**

All payments are due in full at the conclusion of the shoot, unless terms have been established (usually after three bookings)

Renter must have current credit card authorization form on file. Tearlach Productions LLC has the right to charge all amounts that are 60 days past due to renter's credit card.

Tearlach Productions LLC charges a late fee of 1.5% per month to overdue invoices. Renter is liable for any and all costs, including legal fees, incurred by Tearlach Productions LLC in an effort to collect past due charges.

### **Responsibility:**

All equipment is offered for inspection. Failure to inspect waives Renter's right to claim equipment was not in conformity with those requested and in a good state of repair at the time of delivery.

Renter agrees to pay for repairs of damage beyond normal wear and tear. If any rented equipment is lost, damaged or destroyed or for any reason not returned to Tearlach Productions LLC, Renter agrees to replace said equipment of similar kind or pay Tearlach Productions LLC the replacement value of the same.

Renter shall cover loss of income equal to the base rental rate of lost/damaged property or equipment multiplied by the number of days required to repair or replace the lost/damaged item.

If Tearlach Productions LLC discovers that after the rental equipment is returned, that same has been damaged or has parts missing, Renter shall pay all repair costs or replacement part costs of rented equipment. Renter may also be liable for lost rental time incurred in repairing damaged equipment.

If renter fails to return equipment when due or pay rental thereof, Tearlach Productions LLC may declare Renter in default and shall have right to take said equipment from Renter and recover all damages, rental, costs and attorney fees. Renter waives any claim for damage resulting from such an action.

**Cancellation Policy:**

By signing this Rental Agreement, Renter agrees to pay the daily rate for each item booked regardless of cancellation. Whenever possible, Tearlach Productions LLC will rent the cancelled item to another client and waive the fee for the original Renter.
